Although we do not actually provide services, it is our job to ensure that local citizens who seek help receive the quality services and supports they are eligible for and to help them achieve their goals and live as independently as possible. These services are delivered by a network of private providers who contract with Five County Mental Health Authority.

This booklet has been created to help consumers, family members, providers and other interested mem-

bers of the community access valuable information about the Mental Health, Developmental Disability and Substance Abuse services in our area. The information is organized into different categories to assist you in quickly finding information you need.

This directory features over 120 Five County Mental Health Authority Providers, which gives you a choice in the care you receive. We are aware that provider services are constantly changing, so you may find that a service that is listed may have changed. If you cannot find a service which meets your needs or have been discontinued, please contact our HELP LINE at 1-877-619-3761.

This guide is not intended as a referral guide, but as a tool to assist individuals, families and guardians in gathering the information needed to make the best

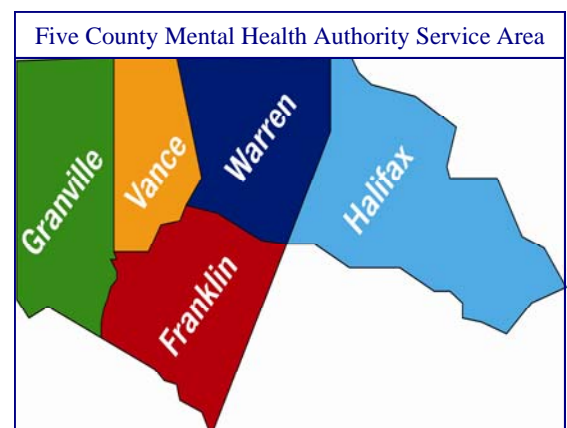
possible choices for care. It will assist you in better understanding the choices that you can make to improve the quality of life for you or a family member.

# Steps to Receiving Behavioral Health Services

Five County Mental Health Authority's STR or Helpline staff will conduct a screening/assessment to determine an individual's need for Mental Health, Developmental Disability or Substance Abuse services. This is done by calling the Five County Mental Health Authority HelpLine at 1-877-619-3761 and discussing your care through the Screening/Triage/Referral (STR) process. If indicated, the LME staff will refer the individual for a comprehensive evaluation to access their needs and develop a preliminary service plan. Once the assessment is completed, the LME will review the plan and authorize services based on the assessment. The LME will then provide the consumer/guardian with qualified providers. (This process is for those consumers being funded with state dollars.)

1. The consumer/guardian selects a provider
2. The selected Provider develops a comprehensive Person Centered Plan and submits it to the LME
3. The LME reviews and authorizes the Person Centered Plan, based on medical necessity and best practices
4. Providers for all authorized services are selected by the consumer/guardian
5. The LME sends the authorization to provide approved services to the selected provider agency/agencies
6. The Provider Agency/Agencies deliver the services based on authorization in the Person Centered Plan.

**STR: Screening, Triage & Referral** – also known as the **HelpLine** – contacted by dialing 1-877-619-3761 for residents of Franklin, Granville, Halifax, Vance & Warren Counties. A series of questions will be asked by a trained worker over the telephone to determine whether the caller needs to be seen within 2 hours for crisis or emergency care, or whether routine services arranged within 7 days are appropriate.

**Provider** – a person or company which provides Mental Health, Developmental Disability or Substance Abuse services.

**Consumer** – a person who receives Mental Health, Developmental Disability or Substance Abuse services; this person may also be referred to as a client, patient or recipient; may also be referred to as a "guest" at the Recovery Response Center.

**LME-** Local Management Entity – Five County Mental Health Authority -- an agency of local government which is responsible for managing and supervising mental health, developmental disabilities and substance abuse services in the counties of Franklin, Granville, Halifax, Vance & Warren Counties.

**Access** — An array of treatments, services and supports is available: consumers know how and where to obtain them: and there are no system barriers or obstacles to getting what they need, when they are needed.

*There are three primary areas of behavioral health care, and for each area there are a variety of programs and services to help consumers of all ages.*

## **Mental Health**

The term mental health includes a broad range of conditions that affect emotional, psychological, and neurological well being. Mental disorders cause distress and/or disability and increase a person's risk of death, pain, or loss of freedom. Examples of familiar mental disorders are anxiety, bipolar disorder, obsessive-compulsive disorder, depression and schizophrenia. Some programs that help restore a person's positive outlook on life include:

1. Individual and group outpatient therapy
2. Psychosocial rehabilitation
3. Children's day treatment
4. Case management
5. Hospital inpatient care

## **Developmental Disability**

Developmental disabilities are severe chronic disabilities that are identified before a person reaches age 22, and which result in limitations in some of the following areas: self-care, language, independent living and learning, mobility, self-destruction, and earning a living. In other words, people with developmental disabilities are likely to need considerable assistance in their day to day lives. Mental retardation is one example of a developmental disability. Some programs that assist people to increase their skills and abilities include:

1. Supported employment
  2. Case Management
  3. Supported living
  4. Respite care
  5. Outpatient therapy

## **Substance Abuse**

The use of any mood altering substance (alcohol and drugs are most common) that adversely affects the user's ability to live successfully is considered substance abuse. Addiction to alcohol, drugs, and other substances generally means compulsive (uncontrollable) use of the substance and results in symptoms of withdrawal when the substance is not used. Both legal and illegal substances can result in substance abuse. Programs that improve the lives of persons and families suffering from substance disorders include:

1. Intensive outpatient treatment
2. Detoxification
3. Individual and group therapy
4. Parenting groups
5. DWI services
6. Supervised living
7. Relapse prevention

## ADULT & CHILD MH/DD/SA SERVICES

**Adult Day Program (Adults only) - (DD)** Services designed to improve the quality of life and promote integration in the community through work preparation, vocational evaluations, supportive employment, and job readiness, coaching and placement.

**American Sign Language - (MH/DD/SA)** A system of communication using hand signs that is used in the United States. It is a language that uses hands, facial expressions, and other bodily behavior to communicate both concrete and abstract ideas.

**Assertive Community Treatment Team (ACTT) - (MH/SA)** An intensive, evidenced-based service for people with severe and persistent mental illness. It utilizes an interdisciplinary team approach, and emphasizes home visits and crisis prevention to avoid hospitalizations.

**Assessment - (MH/DD/SA)** A comprehensive examination and evaluation of a person's need for Mental Health, Developmental Disability or Substance Abuse treatment, services and/or supports according to applicable requirements.

**Child Residential Group Living Level II-IV (Child MH/SA only)** Supervised out of home placement for child consumers needing a stable home/family setting including individual or group counseling and/or skill building. Level refers to the amount of supervision required by the child.

**Community Alternatives Program for Persons with Mental Retardation/Developmental Disabilities (CAP-MR/DD)** A service designed to give persons with MR/DD a cost effective alternative to care in an intermediate care facility rather than having to live in a hospital setting. CAP offers numerous services such as Home & Community Supports, Personal Care, Crisis, Respite, and Day Supports.

**Community Respite-(DD)** Provision of periodic relief to the usual family members and friends who care for a client/patient. A service that provides a

break for parents who have a child with a emotional disturbance. Trained parents or counselors take care of the child for a brief period of time to give families relief from the strain of caring for the child. This type of care can be provided in the home or in another location.

**Community Support (CS) - (MH/SA)** A service designed to work with adults or children and their families to develop a plan and to coordinate services and supports to help them to reach their life goals.

**Community Support Team (CST) - (MH/SA)** An intensive service for adults 18 & older to reduce Psychiatric and/or addiction symptoms, and develop better community living skills.

**Comprehensive Assessment - (MH/DD/SA)** A Comprehensive Assessment is an intensive clinical and functional face to face evaluation of a person's Mental Health, Developmental Disability, or Substance Abuse condition to develop a report and treatment recommendations. It is an evaluation to help decide what kinds of services will meet your needs.

**Crisis/Emergency Services (MH/DD/SA)** 24/7/365 service for individuals experiencing a personal crisis. Includes assessment of need, level of danger to self or others, and, if necessary, placement (voluntary or involuntary commitment) with an appropriate services. Access through 1-87-618-3761.

**Crisis Stabilization - (MH/DD/SA)** An alternative to a hospital where individuals in crisis can go to receive help: the goal is for individuals to return home as quickly as possible. Offered at recovery Innovations in Henderson, NC.

**Day Activity - (DD)** Provides supervision and an organized program during a substantial part of the day in a group setting. It is designed to support a person's personal independence and promote social, physical, and emotional well-being.

## ADULT & CHILD MH/DD/SA SERVICES

### **Day Treatment Services (Child MH/SA only)**

Structured, day long educational program for children ages 3-20 with serious emotional or behavioral problems. The focus is on symptom reduction or stability, increase in coping and interpersonal skills, and behavior management to reintegrate into the community.

**Deaf Interpreting - (MH/DD/SA)** An out patient service provided by trained clinicians who are fluent in sign language and understand the treatment needs of consumers who are deaf, hard of hearing, or deaf-blind.

**Developmental Day - (Child DD only)** A Service which allows individuals to live in a special licensed child care center to promote skill building and family training and support.

**Developmental Therapy - (DD)** A service for those meeting the Developmental Disability criteria, and reflecting the need for instruction, training, or functional activities that address behavioral challenges or skill building in self-care, socialization, & independent living.

**Diagnostic Assessment - (MH/DD/SA)** An intensive clinical & functional face to face evaluation that results in a report regarding whether or not the recipient meets target population criteria for a particular appropriate service.

**DWI - (MH/SA)** A court ordered service for individuals who have lost their license due to a DWI, providing substance abuse education in a group setting.

**Evaluation and Testing - (MH/DD/SA)** Collection of information about an adult's or a child's and his/her family's life, strengths, needs and abilities in order to better develop a plan of services and supports. Phone or face to face evaluation to determine a consumers needs, appropriateness for services and preliminary diagnosis.

**Facility Based Crisis - (MH/DD/SA)** it is a short-term, inpatient crisis recovery center that provides an alternative to medical hospital and state hospital stays. It is available 24/7/365.

### **Facility Discharge and Walk in Clinic - (MH/DD/SA)**

The Facility Discharge and Walk-In Clinic Program ("FADWIC") provides two services. The facility discharge service involves persons who are discharged from a State psychiatric hospital, a community hospital or a residential treatment facility. An evaluation of the person's medication is done, and assistance in paying for medications is arranged. Family or friends that can help the person re-enter community life are identified. For persons having problems with alcohol or drugs, a contact with a Peer Support person is arranged.

The walk-in service provides screening, brief counseling and psychiatric assessment for children and adults who need immediate assistance because of a mental illness and/or substance abuse problem.

**Family Living Low- (MH/DD)** A residential service which includes room and board and provides "family style" supervision and monitoring of daily activities. Individuals live with a family who acts as a provider of supportive services.

### **Foreign Language Interpreting - (MH/DD/SA)**

A highly skilled and educated, preferably certified individual who listens to speech and repeats it back to the deaf or hard of hearing person via sign language interpreting, oral mouthing, cued speech transliteration, or hands-on deaf blind interpreting.

**Group Living - (MH/DD)** A service that provides care (room & board included) in a home-like environment to 5 or more persons. Therapeutic or rehabilitative programming may be provided at low, moderate, or high intensity.

**Guardianship** – A legal guardian is a person appointed by the court to be responsible for certain aspects of care and management when the person is incapable of making decisions for him or herself.



## ADULT & CHILD MH/DD/SA SERVICES

### **Housing and Residential Service - (MH)**

(Must be receiving MH/DD/SA services to access this service). Once you are receiving services, your provider can help you decide which residential supports you will need to achieve your goals: this can include various kinds of assistance such as rent substitutes and help with start up expenses, to help ensure safe, stable housing.

**Independent Living - (MH/DD/SA)** Support for a person living on his or her own. These services include *therapeutic group homes*, supervised apartment living, and job placement. Services teach individuals how to handle financial, medical, housing, transportation, and other daily living needs, as well as how to get along with others

### **Inpatient Crisis Diversion Program - (MH/DD/SA)**

Mental Health treatment provided in a hospital setting 24 hours a day. Inpatient hospitalization provides: (1) short-term treatment in cases where a consumer is in crisis and possibly a danger to his/herself or others, and (2) diagnosis and treatment when the patient cannot be evaluated or treated appropriately in an outpatient setting.

### **Inpatient Hospitalization - (MH/DD/SA)**

Halifax Regional Medical Center & Holly Hill Hospital provide crisis diversion inpatient hospital stays, with comprehensive medical capacity, as an alternative to state hospital stays. They are available 24/7/365.

### **Intensive In-Home Services (IIH) (MH, DD, SA)**

A team and family approach to provide intensive services for children who have serious emotional disturbances, complex family challenges, or behavioral problems likely to result in out-of-home placement.

### **Juvenile Justice/Substance Abuse/Mental Health Partnership (previously called MAJORS) (Child SA)**

A partnership between the Area Authority and the Juvenile Court system to provide assessment and services for substance abusing and dependent juveniles.

**Lake Area Recovery Home - (MH/SA)** A facility that provides a safe, drug-free home for up to 17 adult men who have a demonstrated history of alcohol or drug problems, and who have made a commitment to sobriety and recovery. Participants are educated about the principles of recovery, and introduced to recovery support programs such as AA, NA, and employee/professional assistance programs.

**Long Term Vocational Support - (MH/DD)** The service begins after an intensive phase of job coaching, and provides regular monitoring and support to assess and ensure employment stability.

**Medication Management - (MH/DD/SA)** Evaluation of medication options by an approved physician to determine which medicine is best, how it should be taken, and whether it is working.

**Mobile Crisis - (MH/DD/SA)** A service that provides immediate evaluation, triage, and crisis response to address symptom reduction, harm reduction, & crisis prevention or stabilization. The service provides immediate telephonic access, and is mobile to accommodate expedited face to face contact with a person 24/7/365.

**Multi-systemic Therapy- (MH)** Multi-systemic Therapy (MST) is a time-limited, intensive family and community-based treatment that addresses the multiple determinants of serious anti-social behavior in juvenile offenders. MST addresses the factors associated with delinquency across youths' key settings, or systems (e.g., family, peers, school, neighborhood). Using the strengths of each system to foster positive change, MST promotes behavior change in the youths' natural environment.

**Outpatient Group: (SA)** The treatment of psychiatric disorders through scheduled therapeutic visits between the therapist and the patient in the contact of a group setting of at least three and not more than twelve participants with a common goal.

## ADULT & CHILD MH/DD/SA SERVICES

**Outpatient Therapy-(DD, SA)** The treatment of psychiatric disorders through scheduled therapeutic visits between the therapist and the individual. Services provided by or under the supervision of a licensed therapist.

**Outpatient Treatment (Individual, Family, & Group) (MH)** A service designed to meet clinically significant behavioral or Psychiatric/psychological symptoms. It includes counseling, psychotherapy, medication therapy, and other specialized therapies.

### **Outpatient Services**

A collection of services for persons with mental illness or addiction disorders. They may include any of the following but are not limited to assessment, medication management, psychotherapies, family therapy, care coordination or case management, supportive employment programs, housing assistance, rehabilitation programs and activities, Assertive Community Treatment (ACT), Homeless Outreach, prevention programs, and others. Outpatient services can be provided in a variety of settings, including the person's home, and contain a few or any number of service elements.

**Peer Support: (SA)** This service provides a supportive relationship between a certified Peer Support Specialist (self-identified as a person in recovery) and another individual in need to model and empower changes and decisions to enhance mental health or substance abuse recovery. Peer support services can include drop in centers, warm lines, peer respite care or support groups. Peer support services are often a part of rehabilitation and recovery programs.

**Personal Assistance (DD)** A support service that provides assistance in personal or regular living activities in the home, in skill development, and in supportive accompaniment to community activities or specialized habilitation programs.

**Psychiatric Residential Treatment Facility (PRTF) (MH, SA Child)** Provides care for children who have mental illness or substance abuse/dependency and who are in need of services in a non-acute inpatient facility. This service may be provided when an individual does not require acute care, but requires supervision and specialized interventions on a 24-hour basis to attain a level of functioning that allows subsequent treatment in a less restrictive setting. (Licensed by Division of Facility Services)

**Psychological testing (MH, DD, SA)** Written, visual, or verbal tests used to assess the consumers mental and emotional functioning. Tests can assess achievement, ability, personality, and neurological functioning.

**Psychosocial Rehabilitation (PSR) (MH, SA)** A service designed to help adults with psychiatric disabilities to focus on skill and resource development to increase the ability to live independently in the community.

**Rapid Response Homes - (MH)** A specialized crisis respite service to provide a short-term community based option for a child while the family and treatment team work to determine longer term therapeutic options.

**Recovery Home - (MH/SA)** A rehabilitation facility for individuals, such as mental patients or substance abusers, who no longer require the complete facilities of a hospital or other institutions but who are not yet prepared to return to their communities.

**Residential Treatment – Level II Family Type (Foster Care) (MH)** Provides a structured and supervised environment offered in the family setting. This level of care responds to consumers' needs for more active treatment and interventions. (Licensed by DSS under GS 131-D family foster care and therapeutic foster care.)



## ADULT & CHILD MH/DD/SA SERVICES

**Residential Treatment – Level II Program Type: (MH)** Is responsive to the need for intensive, interactive, therapeutic interventions, within a program setting, which still fall below the level of staff secure/24 supervision or secure treatment settings.

**Residential Treatment – Level III (MH)** Is responsive to the need for intensive, active therapeutic intervention, which requires a staff secure treatment setting in order to be successfully implemented. Staff is awake during sleep hours and supervision is continuous.

**Residential Treatment – Level IV (MH)** A service which provides school, psychological and psychiatric consultation, nurse practitioner services, vocational training, recreational activity and other relevant services in the context of residential treatment. Typically the treatment needs of consumers are so extreme that these activities can only be undertaken in a therapeutic context. Staff is awake during sleep hours and supervision is continuous.

**Respite Care - (DD) Respite Care**  
A service designed to provide temporary care for a person with a disability who ordinarily lives with family or friends, or to assume temporary responsibility for care of the person in his/her own home. This service provides back-up support and in some cases relief to persons responsible for care of ill or people with disabilities who ordinarily live in their household.

**Retirement Activities Program for Individuals with Developmental Disabilities (RAPIDD)- (DD)** A program which provides support to people with mental retardation and other developmental disabilities over the age of 60 so they may participate in activities at the local Senior Center and in other retirement activities in the community.

**SA Halfway House for Men and SA Halfway House for Women - (MH/SA)** A clinically managed, low intensity, licensed, residential service where the primary purpose is the rehabilitation of individuals who have a substance abuse disorder.

**Substance Abuse Intensive Outpatient Program (SAIOP) (MH, SA)** A substance abuse program that provides multiple sessions per week to learn new behaviors, to participate in self-help groups, and to practice relapse prevention strategies.

**SACOT - (MH)** Substance Abuse Intensive Outpatient Program-A program that provides comprehensive treatment for individuals suffering from alcoholism and substance abuse. The Intensive Outpatient Program enables you to seek treatment for your addiction while continuing to work and take care of your family.

**Supported Employment - (MH/DD)** Supportive services that include assisting individuals in finding work; assessing individuals' skills, attitudes, behaviors, and interest relevant to work; providing vocational rehabilitation and/or other training; and providing work opportunities. Includes transitional and supported employment .

**Targeted Case Management - (DD)** A service designed to provide case management and service coordination for MR/DD individuals.

**Therapeutic Foster Care - (MH)** A specialized program for children with special physical, psychological, or emotional needs who are unable to live with their natural family for any of a variety of reasons. The children are placed with specially trained foster parents while a plan is made to provide for the child's long-term care.

## Other Behavioral Health Definitions:

**Crisis** —Response to stressful life events that may seriously interfere with a person’s ability to manage. A crisis may be emotional, physical, or situational in nature. The crisis is the perception of and response to the situation, not the situation itself.

**Managed Care**—A health care delivery system that attempts to keep cost down by managing the care to eliminate unnecessary treatment and reduce expensive hospital care.

Pre-authorization-The process of approving use of certain resources in advance rather than after the service has been provided.

**Prior Authorization**– A managed care process that approves the provision of services before they are delivered.

**Public Services**-Publicly funded mental health, developmental disability and substance abuse services delivered by public and private providers.

**Referral** —Establish a link between a person and another service or support by providing authorized documentation of the person’s needs and recommendations for treatment, services, and supports. It includes follow-up in timely manner consistent with best practice guidelines.
